1. Tenders shall be submitted in the prescribed format separately for each vehicle in a sealed cover super scribing **“Tender for purchase of vehicle bearing Regd. No KA 25 N 7119”** addressed to: The General Manger, Karnataka Vikas Grameena Bank, Head Office Dharwad.
  2. Tenderes can submit tender cum auction for one or more or all the vehicles,
  3. Duly completed tender cum auction documents shall be submitted to our office at the address given above on or before 27/6/2017 before 2.00 PM. Tenders may be opened on 27/6/2017 at 4.00 PM or **suitable date as decided by the Bank** in the presence of intending bidders or their Representatives who may be deputed to remain present at the time of tender opening. Only one Authorized Representative will be allowed to witness the tender opening and for auction upon submitting the authorization letter issued by the bidders. Bids received late will be **rejected**.
  4. EMD, a sum of Rs.10,000/- has to be deposited along with application fee by way of DD payable at Dharwad.
  5. The bid amount to be paid by way of cash/DD favoring Karnataka Vikas Grameena Bank payable at Dharwad. The person on being declared to be successful bidder shall deposit 25% of sale price, less EMD deposited **immediately**.
  6. The balance payment shall be paid within three days from the date of auction, failing which; the amount paid shall be forfeited.
